#### **CEO** Update

- Dana went in front of LAUSD due to concerns with enrollment and fiscal stability. Dana had to remind them the school had to make adjustments and change projections due to being a year two school and the impact of enrollment due to COVID-19. Revised 2020-2021 budget. Provided update on enrollment target. Provided projection for enrollment of 90 scholars in 2022 as AMA add another grade level. Year 5 will have 250 scholars. This was unique to highlight because initial petition was much higher.
- Waiting on WASC accreditation coming in February. Walter Wallace communicating to CDE with material revision helped AMA complete a full review for admission.
- Sony Music partnership with AMA Foundation which will be announced soon with career technical education school in Los Angeles. This will highlight social justice and corporate responsibility to help assist with Wellness Program for students with IEP that may include counseling, wellness activities, tutoring and more. This is the beginning of the partnership. This will help recruit more families and students.
- PPP Loan second round will be additional support for school to help manage fiscal operations.
- Dana will schedule a call with board members will review 3 year strategic plan draft, finalize and approve the plan.
- Plans are underway to launch "virtual real world learning" which includes 3-D design class and get industry leaders feedback through Q&A. Innovation X was a project created last year and will continue virtually this year. Board members had questions about calling project an internship. Recommendation is to hold separate meeting to discuss internship.
