Walter Wallace explained the key parts of LCFF funding source, categories for special populations and changes in the LCFF formula for funding. The report is a way of accountability for how AMA spend money to meet student needs. The LCFF Budget Overview breaks out how funding is broken down. We had to work with parents to develop the Learning Continuity Plan which we had to identify areas we need to accomplish to meet needs of students. Close to \$104K is in the plan to help high need students including additional supervision for those students falling behind, facility cleaning cost, counseling services, money for transportation, supplies and professional development for staff.

There were 8 parents who attended the parent meeting and AMA CEO and Walter Wallace explained how funding is spent. They fielded questions from parents and provided updates. Next parent meeting is on 12/15/20.
